Baseline pricing is currently active. The August 2026 diesel average of \$1.887/L is at or below our \$1.90/L baseline, so no fuel surcharge applies. Your rate stays as quoted — **\$130.00/hr brokered** and **\$155.00/hr retail**. This continues the Baseline pricing carried over from July's monthly review.

HOW IT WORKS

1

We set a baseline diesel price

Our hourly rates are built around diesel at \$1.90/litre. When diesel is at or below that price, your rate stays as quoted — no surcharge applied.

2

Diesel prices are monitored monthly

We reference the Natural Resources Canada weekly average for Toronto — a publicly available, government-published benchmark anyone can verify.

3

A tiered surcharge applies when prices rise

For every \$0.10/L above \$1.90, a 5% surcharge is added to your hourly rate — always as a separate line item on your invoice.

4

When fuel drops, so does the surcharge

If diesel returns to \$1.90/L or below, the surcharge is removed entirely. You will always be notified in writing before any tier change takes effect.
